SUBJECT: CITY ORDINANCE PERTAINING TO DISPLAY OF YARD SALE SIGNS
TO: ANY PERSON(S) CONDUCTING YARD SALES
FROM: THE CITY OF PIONEER VILLAGE

YARD SALE SIGNS ARE ALLOWED IF THEY COMPLY WITH THE FOLLOWING:
ON PREMISES UNLIGHTED YARD SALE SIGNS, NOT EXCEEDING SIX
6) FEET, WHICH ADVERTISE THE AVAILABILITY FOR SALE OF
PERSONAL PROPERTY IN RESIDENTIAL AREAS.

PENALTIES:
ANY PERSON WHO VIOLATES ANY OF THE PROVISIONS OF THIS ARTICLE FOR WHICH NO OTHER
PENALTY IS PROVIDED SHALL UPON CONVICTION BE FINED IN AN AMOUNT NOT LESS THAN
TWENTY DOLLARS (\$20.00) NOR MORE THAN TWO HUNDRED FIFTY DOLLARS (\$250.00). EACH DAY OF
THE VIOLATION SHALL CONSTITUTE A SEPARTE OFFENSE. ANY PERSONS VIOLATING THIS
ORDINANCE MAY ALSO BE FOUND GUILTY OF A CIVIL OFFENSE. THE CIVIL FINE SHALL BE NO LES
THAN TWENTY DOLLARS (\$20.00) NOR MORE THAN TWO HUNDRED FIFTY DOLLARS (\$250.00)

PARKING:
(A) ALL PERSONS ATTENDING CONDUCTING SUCH SALES SHALL BE RESPONSIBLE FOR INFORMING
ALL CUSTOMERS THAT PARK ONLY ON THE SIDE OF THE STREET WHERE THE YARD SALE IS
LOCATED, AND NOT BLOCK ANY DRIVEWAYS, OR POTENTIAL CUSTOMERS TO MOVE THEIR
VEHICLE IF SUCH VEHICLE IS IMPEDING THE FLOW OF TRAFFIC ON THE STREET.
(B) NO MORE THAN TWO VEHICLES AT A TIME MAY PARK ON THE STREET DIRECTLY IN FRONT OF
THE YARD SALE, AND MAY PARK ONLY ON THE SAME SIDE OF THE STREET AS THE YARD
SALE.

OFF PREMISES SIGNS ARE NOT PERMITTED
NO WARNING CITATIONS WILL BE ISSUED
