

ORDINANCE NO. 2023-05

AN ORDINANCE AMENDING THE CITY OF PIONEER VILLAGE, BULLITT COUNTY, KENTUCKY, ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2022, THROUGH JUNE 30, 2023.

WHEREAS, on the 28th day of June, 2022, the City Council of the City of Pioneer Village did adopt Ordinance No. 2022-05 AN ORDINANCE ADOPTING CITY OF PIONEER VILLAGE, KENTUCKY, ANNUAL BUDGET FOR FISCAL YEAR JULY 1, 2022, THROUGH JUNE 30, 2023.

WHEREAS, it is now necessary to amend said budget to more accurately reflect the revenues received and the expenditures made, now, therefore;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PIONEER VILLAGE, as follows:
